SINCE 2014, GRACE HAS ENDED HOMELESSNESS FOR OVER 3,200 PEOPLE, HELPING TO REDUCE LOCAL HOMELESSNESS BY 40%. GRACE HAS RECEIVED LOCAL, STATE AND NATIONAL RECOGNITION FOR PROVIDING HIGHLY EFFECTIVE, COMPASSIONATE, AND COST-EFFECTIVE SERVICES TO THE GAINESVILLE COMMUNITY.**
